Dear Mr. Davison:

The purpose of this letter is to update Sacramento County staff regarding an adjustment to the Sacramento Area Flood Control Agency (SAFCA) Development Impact Fee (DIF) rates.

The SAFCA DIF was adopted by the SAFCA Board of Directors on May 15, 2008 (Resolution No. 08-048), and went into effect on January 1, 2009. Various provisions of the DIF Program were adjusted by the SAFCA Board on March 18, 2010 (Resolution No. 10-034). On October 20, 2016, the SAFCA Board updated the DIF program by the adoption of Resolution No. 2016-110, including an increase in rates. This letter serves to notify the County of the increase in the DIF rates. Consistent with the 60-day notification requirements of the Collection Agreement that SAFCA has with the County, the fee increase should then be effective 60 days after the date of this letter, or on January 1, 2017. The attached Table 1 contains the updated DIF rates.
